Adjustment for Tiens Gratitude Fund (TGF)

1. With effective from bonus month 201003, requirement for TGF maintenance is adjusted as below:

- i) **5 star and above** distributors: minimum monthly personal sales remained as **200BV**
- ii) **4 star and below** distributors: minimum monthly personal sales is adjusted to **100BV**

2. The management has decided to pay out part of the TGF to the respective beneficiary. Upon death, validated death certificate must be submitted to the company for arranging part payment of RM1500* within 7 working days. Balance of the fund will be paid after 15th of the following month.

Terms and Conditions:

A) Newly Join TGF members:

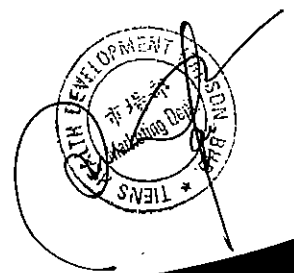
- i) With maintain of 6 consecutive bonus months, the participating distributors (PD) is entitle to enjoy the benefit of TGF from 7th bonus month onwards.

Example:

Mr. A joined TGF in 201003 and continued to maintain for 6 consecutive months. By 7th month (201009), his beneficiary is entitled for TGF* if he deceased in that particular month.

- ii) Special requirement for aged 70 and above:
 - **5 star and above**: monthly personal sales of **300BV** for **6 consecutive months** and thereafter **200BV** from **7th month** onwards.
 - **4 star and below**: monthly personal sales of **300BV** for **6 consecutive months** and thereafter **100BV** from **7th month** onwards.

B) Existing inactive TGF members

i) Inactive TGF members (who has maintained at least 6 months) can be re-active by maintaining 3 consecutive months within promotion period. From the 4th bonus month the TGF status will be reactivated.

ii) Special requirement for aged 70 and above:

- **5 star and above:** monthly personal sales of **300BV** for **3 consecutive months** and thereafter **200BV** from **4th** month onwards.
- **4 star and below:** monthly personal sales of **300BV** for **3 consecutive months** and thereafter **100BV** from **4th** month onwards.

Questions and Answer

Q1: I'm a 4 star distributor upon join TGF, How much I need to maintain after promoted to 5 star?

A1: You are required to maintain 100BV when you are 4 star ; after promoted to 5 star are required to maintain 200BV .

Q2: I am a TGF member. However, I discontinued maintain after a few months, how do I reactivate my account?

A2: i) If you have maintained for 6 months in the past, you can just maintain for another 3 consecutive months (within the promotion period) to reactivate your account. From the 4th month onwards, you are entitle for TGF

ii) If you have maintained less than 6 months in the past , you can either choose to top up with triple sales volume or re-qualify to entitle for TGF.

Q3: Is the above a permanent promotion for TGF?

A3: No, it is only applicable from **201003 to 201005 bonus month**. Started from 201006 bonus month, members need to maintain 12 consecutive months. Members only can entitle for TGF by 13th month.

Q4: How many existing TGF members?

A4: We have 9309 members up to 201001, 1234 members are active. With this promotion, we strongly believe more members can be activated and thereafter increasing the amount of TGF, giving maximum benefit to the deceased family.
